NOTIFICATION

GUJARAT TOWN PLANNING & URBAN DEVELOPMENT ACT 1976

No. GH/V/ 4 of 2012/UDA-1909-1218-L- WHEREAS, Bharuch Area Development Authority was constituted as area development authority under sub-sections(1) and (2) of section 3 and sub Section (1) of Section 6 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) vide Government notification No. GHB-20-UDA-1177-646(2)-Q Dated 30.01.1978.

WHEREAS, The Ankleswar Development Authority was constituted as development authority under sub Section (1) Section 6 of Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) vide Government notification No. GHB-20-UDA-1177-646(2)-Q Dated 30.01.1978.

AND WHEREAS after constitution of Bharuch ADA and Ankleswar ADA the Government is satisfy for the purpose of which this authority where constituted and there is increased development within the surrounding complementary to both the towns.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1), (2), (2-A) of section 22, sub-section 5 of 22, sub-section 3 of section 23 and section 108 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) the Government of Gujarat hereby;

- (i) Declares the areas specified in column 3 of the schedule appended here to be the Urban Development Area of Bharuch Area Development Authority & Ankleswar Area Development Authority.
- (ii) Amalgamates and defines the areas within the limits of Bharuch Area Development Authority & Ankleswar Area Development Authority and specified in column 4 of the said schedule to be the limits of the said Urban Development Areas;
- (iii) Constitutes the Authority for the said Urban Development Areas to be called the Bharuch-Ankleswar Urban Development Authority and shall consist of the following members And declares Bharuch as Authority's headquarter.
- (iv) Declare properties and rights of Bharuch Bharuch Area Development Authority and Ankleswar Area Development Authority ceases to exist and vest in Bharuch-Ankleswar Urban Development Authority.


